- **Spaying or Neutering is required** as soon as your Veterinary Doctor says it can be done. You are required to send proof when completed to the Breeder. This could be as early as 5 or 6 months old.
- **Information on the micro chip will be sent to you if necessary at the time of proof of spaying or neutering completed.**

- Fancy Feast kitten. **They have had only spring bottled water.** Of course, a water fountain would be
- great to encourage to drink water more frequent. Make any changes slowly in regards to water or food.
- Wet food 2 x's a day, am and pm, Dry kitten available all the time, Water available all the time.

Buyer agrees to the following condition in regards to their new Bengal Cat/Kitten:

* Under no circumstances will this cat/kitten or its progeny be sold, leased or given away to any pet shop, research laboratory, animal shelter or similar facility. Should buyer be unable to keep said kitten/cat the Breeder is to be notified. Breeder will try to help find a suitable place for the Bengal, but it is up to the Buyer to find a new home for their Bengal. If possible the Breeder will take possession of the Bengal, to find a suitable home (no monies will be refunded to the Buyer). If for some reason Buyer is unhappy with their new kitten, a replacement can be discussed, it might be at a later date, discretion of the Breeder.

*The Bengal Cat/Kitten will be kept indoors and not allowed to roam freely outside. Some can be harness trained and walked on a leash. Always use the proper quick release collar and supervision when on a harness.

*If this Bengal Cat/Kitten is found to be neglected or mistreated, Buyer will surrender said cat/kitten to the Breeder, unconditionally. When Bengal is being sold as Pet Only, no Breeding with any other feline is permitted, Bengal or not. Accidentally or not. Spaying and Neutering must be completed at the appropriate time. Otherwise you will be considered Not caring for your Bengal properly and will have to be surrendered to Seller.

*Buyer is to provide remainder of vaccinations necessary, following the Vaccination schedule. This was outlined on page 2.

*It is recommended the your new Bengal be isolated from others pets in the home in the beginning. Just a safe place just for him/her. Buyer should have taken all precautions with present feline members all necessary vaccinations and or blood test; to be confident none are diseased and or carrier of such. Buyer has seven days to have their veterinarian exam of their new kitten. If kitten/cat is found to be medically deficient with an untreatable or life threatening problem, it must be reported to Breeder immediately. Kitten will be replaced as soon as a suitable replacement can be found. It is the responsibility of the Buyer to provide immediate veterinary care to any cat/kitten showing signs of illness or distress. Failure to do so will render warranty null and void. Under no circumstances is kitten/cat to be euthanized prior to notification by Buyer to Breeder. If kitten dies during warranty period despite veterinary treatment, replacement will be made only if a veterinarian certifies cause of death with an appropriate necropsy. A replacement of comparable quality and value as available within one year will be offered.

*The kitten/cat is to be of sound health upon arrival. Two if not more vets checks were given by the Breeder thru their Veterinary Doctor. This kitten is guaranteed against congenital defects, the kitten will be replaced only if an appropriate necropsy is performed by licensed veterinarian and a veterinarian's certificate is provided as proof of cause of death. A replacement will be made as available, at the discretion of the Breeder.

*When kitten is sold other than as a Breeder. It is Mandatory at the earliest time allowed by Buyer's Veterinary recommendation that the kitten be neutered (male) or spayed (female). Proof of such is to be given to Breeder, at such time micro-chip information will be forwarded via email (usually) and the "blue slip" Sent by mail. Buyer can then submit for registration and pedigree of their kitten at their expense.

*Kitten(s) will be released to Buyer when paid in full at time of pick-up or paid in full prior to delivery. Kitten/cat will be released at the discretion of the Breeder with only the best interest of the kitten/cat in mind.

*Shipping via the airlines, specific shipping arrangements will be made for each individual situation. Health certificates will be required, proper crating and airlines appointments. All kittens/cats must be paid in full, agreement/contract signed and returned, along with shipping fees prior to shipping.

This contract is legally binding to all parties involved. Any legal fees incurred upholding this contract will be paid by the Buyer. Venue is in the State of Texas and in the County of Comal. Buyer's signature indicates full agreement with the terms within the contract. Facsimile signatures shall be enforceable as an original if original is otherwise unavailable.
